Mr Thomas Ching Wing-hong is a distinguished entrepreneur with extensive experience in the insurance industry of Hong Kong. He founded Consolidated Marketing Group International Wealth Management Limited in 2005, where he currently serves as Managing Director. Over the years, Mr Ching has focused on developing high-end life insurance services, providing comprehensive wealth planning and risk management advisory to individual and corporate clients through partnerships with private banks, retail banks, commercial banks, and multinational financial institutions.

With keen market insight and an innovative spirit, Mr Ching pioneered the introduction of mega-size life insurance to the Asian market two decades ago. Since graduating, Mr Ching has actively engaged with fellow alumni, aiming to unite alumni resources to share experiences with younger students and support the University's continued growth.
